## 1. Who are we?

[Satellic](#) acts as [Controller](#) as regard to your [Personal data](#). We collect, process and store your personal data using the appropriate security measures and in accordance with the applicable data protection legislation, among which the [General Data Protection Regulation \(GDPR\)](#).

## 2. What is the scope of this Privacy Policy?

The aim of this Privacy Policy is to give you information on how we handle and treat your Personal data. It describes how we use your Personal data, which Personal data we collect, how we collect it, on basis of which legal grounds we collect and process your Personal data, how long we store your Personal data and with whom we share it. Finally, it sets out your rights regarding our processing of your Personal data.

This Privacy Policy covers the processing of the Personal data of:

- (Contact persons of the) [Users](#);
- (Contact person of) Any other party with which Satellic does or intends to do business (e.g. prospects, visitors of the Satellic offices, suppliers);

Satellic was appointed as the “single Service Provider” in the sense of the [Road Pricing Regulations](#) by [Viapass](#). Whenever Satellic acts on behalf of Viapass and processes your Personal data with the purpose of calculating and collecting the [Toll](#) on behalf of Viapass and to assess whether a [Vehicle](#) has paid the appropriate Toll or is eligible for an exemption, Satellic acts as a [Processor](#). This processing by Satellic on behalf of Viapass is subject to a Data Processing Agreement. Notwithstanding, by means of this Privacy Policy, we would like to describe which Personal data we process when we act as a Processor: the corresponding information is written in this Policy in “bold script”.

## 3. Why do we collect your personal data?

### ❖ [I am a Website Visitor](#)

We collect your Personal data to:

- operate our Website
- measure the effectiveness of the content and use of our Website;
- increase the ease of use of the Website and protect it from attacks;
- deal with enquiries, requests and complaints (e.g. sent via the online contact or request forms).

### ❖ [I receive the Satellic newsletter](#)

We collect your Personal data to:

- inform you of any event, news, survey or topic that may be interesting for you.

### ❖ [I am a \(contact person of the\) User](#)

We collect your Personal data to:

- **calculate and collect the Toll on behalf of Viapass;**
- **enable the [Toll Charging Authorities](#) to assess whether a Vehicle has paid the appropriate Toll or is eligible for an exemption;**
- fulfil our contractual obligations as administrator of your User Account, to deliver OBUs and to handle returned OBUs;
- fulfil our legal obligations (e.g. to respond to the requests from governmental authorities, such as supervisory agencies, fiscal authorities and investigation agencies);
- respond to your enquiries, requests and complaints;
- avoid and investigate (potential) Personal data breaches and (potential) security incidents;
- enhance and improve our services;
- identify trends and determine the effectiveness of our business activities;

- perform dispute management (e.g. enforce our contractual terms and conditions, pursue legal remedies or limit the damages we may sustain);
- manage the lifecycle of the OBU;
- manage the relationship with you and Viapass.

❖ *I am (a contact person of) any other party with which Satellic does or intends to do business (e.g. prospects, visitors of our offices, suppliers)*

We collect your Personal data to:

- fulfil our contractual obligations regarding (e.g. orders, invoices);
- fulfil our legal obligations (e.g. to respond to the requests from governmental authorities, such as supervisory agencies, fiscal authorities and investigation agencies);
- respond to your enquiries, requests and complaints;
- sustain public relations and press contacts;
- generate statistics and market researches;
- perform dispute management (e.g. enforce our contractual terms and conditions, pursue legal remedies or limit the damages we may sustain);
- avoid and investigate (potential) Personal data breaches and (potential) security incidents;
- manage the relationships with you;
- ensure the security of our offices, the safety of our employees and visitors, as well as guarantee the security of our assets and information located in our premises.

❖ *I am an Applicant*

We collect your Personal data to:

- assess your suitability for the position you applied for at Satellic (or determine if another position could match your profile at a later stage);
- prepare a contract, in case we decide to hire you.

## 4. Which Personal data do we collect and how do we collect it?

❖ *I am a Website Visitor*

We may obtain your Personal data when you fill in one of the online contact forms available on our Website:

- The “Contact & Complaints” form

When you fill in the “Contact & Complaints” form, we may collect the following Personal data: your name, e-mail address, licence plate number, OBU serial number, customer number, as well as the content of your message, including the documents you upload.

- The “Data Subjects’ Request” form

When you fill in the “Data Subjects’ Request” form, we may collect the following Personal data: your name, e-mail address, date of birth, address, telephone number, as well as the content of your message and a proof of your identity.

We may also obtain your Personal data via cookies when you use the Website. Cookies are small text files which are set on your browser, your computer or mobile device. The Website asks your browser to store the cookie on your device in order to remember information about you, such as your language preference or login information to ensure that your device is recognised when you revisit the Website.

We use first-party cookies as well as third-party cookies, session cookies and persistent cookies.

“First-party cookies” are cookies installed by Satellic itself on its Website.

“Third-party cookies” are cookies installed by other parties (e.g. Cookiebot, Google Analytics).

“Session cookies” are deleted from your computer or devices when you close your browser.

“Persistent cookies” remain stored on your browser or devices until deleted or they reach their expiry date.

When you sign up on the Website to receive our newsletter, we collect the following personal information: your name and e-mail address. You can opt-out from our newsletter (sent via e-mail) at any time and free of charge by using the unsubscribe link which is in the footer of all the newsletters you receive, or by sending an e-mail to [marketing@satellic.be](mailto:marketing@satellic.be).

❖ [I am a \(contact person of the\) User](#)

1) The Personal data we collect *because you give it to us* may include the following:

- When you create a User account via the Road User Portal:
  - o User identification information e.g. name, address, e-mail address, telephone number, VAT, IBAN, BIC, password and username.  
When you are the contact person of the User, we collect your name and professional e-mail address.
  - o Vehicle information e.g. License Plate Number (LPN), country of origin, [Gross Combination Weight Rating](#), [Emission Class](#) and Vehicle registration papers
- When you create a User account via a Service Point:
  - o User identification information e.g. name, address, e-mail address, VAT and OBU PIN.  
When you are the contact person of the User, we collect your name and professional e-mail address.
  - o Vehicle information e.g. License Plate Number (LPN), country of origin, Gross Combination Weight Rating, Emission Class and Vehicle registration papers
- When you execute payments via the Road User Portal or a Service Point:
  - o Payment transaction information e.g. payment means (fuel card, debit and credit card, cash...), payment regime (post-paid or prepaid), timestamp of the transaction, amount of the transaction and channel of the transaction (Road User Portal or Service Point (in which case the location of the Service Point is also mentioned)).
- When you interact with our Website, the Road User Portal or our Customer support:
  - o A subset of the User identification information.
  - o A record of a summary of the call, chat, e-mail and postal exchanges.
- When you enter our offices and sign in at our reception desk:
  - o name, company name of the employer, time of your arrival and departure, name of the host and your picture (collected via the cameras located at the entrance of our offices).

2) The Personal data we collect *from the OBU when your Vehicle is driving in Belgium* may include:

- **Toll information e.g. date of usage, Toll road on which the Vehicle has driven, starting time, distance, amount of the Toll (taking into account the Vehicle information). The OBU sends this Toll information to our backend systems and we use this information to create your Payment Documents.**
- Journey information e.g. time stamp, GPS position, speed, direction and OBU ID. In case you have opted in for a Journey Visualisation, the OBU sends this journey information to our backend systems and we use this information to create your Journey Visualisation.

3) The Personal data we collect *from the enforcement equipment when your Vehicle is passing under it or next to it* may include:

- **An alpha-numeric read of your Licence Plate Number (LPN) and/or photographic images of your Vehicle.**
- **If the Toll has been paid or if the Vehicle is eligible for an exemption, the alpha-numeric read of your LPN and/or the photographic images of your Vehicle are deleted immediately.**
- **If the Toll has not been paid, we prepare a dossier containing the details of the violation of the Belgian Road Pricing Regulations: location of the violation, time stamp of the violation, reason of the non-compliance to the Belgian Road Pricing Regulations, information coming from external databases such as the one of the DIV (Vehicle Registration Service) and the one of the CBE (Crossroads Bank for Enterprises) (hereafter called "enforcement record"). Satellic provides this enforcement record to the Toll Charging Authority responsible for the area in which the violation was committed. On this basis, the Toll Charging Authority may issue a fine for non-payment of the Toll. If there is not a 100% match between the alpha-numeric read of your LPN and the photographic images taken by the enforcement**

equipment, the photographic images of your Vehicle will be manually checked by an operator employed by Satellic before sending the enforcement record to the Toll Charging Authority. Additionally, before issuing a fine for non-payment of the Toll, the enforcement record is verified by an operator employed by the Toll Charging Authority. As a rule, your Personal data will not be used for automated decision-making. Automated decisions are defined as decisions about individuals that are based solely on the automated processing of data without human involvement and can impact an individuals' legal rights and/or circumstances, behaviour or choices.

4) The Personal data we collect because they *are publicly available*.

5) The Personal data we collect because they *are given to us by others, such as:*

- a [Business Partner](#), who provides us with your contact details and Vehicle information in order to help you register for a User Account and order services. Satellic will process the personal data obtained from a Business Partner in accordance with the current Privacy Policy. However, you may have a separate agreement with the Business Partner that will control that Business Partner's use of your Personal data. In that case the current Privacy Policy does not apply to the information held by that Business Partner.
- your employer, who opted in for the journey visualisation we offer. In this case, Satellic processes the information on behalf of your employer. If you want to exercise your data subject's rights pursuant to art 15-22 of the GDPR, you should direct your request to your employer in his quality of Controller.
- A third-party service provider that we use in the framework of our Additional Services (e.g. NV Tunnel Liefkenshoek, which provides us with the OBU ID, the LPN, as well as the day and time on which the Vehicle has passed through the barrier). Only in case you have ordered this Additional Services we use this information to create your invoice for the Additional Service.

When you are the contact person of any other party with which Satellic does or intends to do business, we collect your name and professional e-mail address.

2) The personal data we collect because they *are publicly available*.

The Personal data we collect *because you give it to us* may include the following:

- your contact details e.g. name, address, e-mail address, telephone number;
- your personal data e.g. date and place of birth, nationality, gender, marital status;
- information on your educational and professional background, trainings and certifications;
- data generated by us e.g. interview report (including reference check and background check) and assessment results;
- any other Personal data required pursuant to the law.

## 5. What are the legal grounds for processing your Personal data?

❖ [\*I am a Website Visitor\*](#)

When you fill in one of the online contact forms on the Website, we process your Personal data based on our legitimate interests (handling your enquiries, requests and complaints in such a way that we provide you with the very best service) or to comply with a legal obligation (handling data subject's requests, as required by the GDPR).

We process your Personal data collected via necessary cookies based on legitimate interests (see section 3). For all other types of cookies we need your consent.

### **How can you delete or block cookies, or change your setting ?**

You can accept all cookies, reject all cookies or manage your cookies via the cookie banner that appears on our Website when you first visit the site. If you refuse cookies only essential cookies will be set on your browser. If you have given for statistical cookies your consent, you have the right to withdraw your consent. You can at any time do so by means of the [cookie manager](#).

In case you decide to withdraw your cookies consent for any reason, your choice will be taken into account on our Website but unfortunately we cannot spread this information to third parties such as Google. We recommend that you delete your cookies from your browser to make sure those third parties cannot continue to track you outside the Website environment

To change your cookies settings via your browser, you usually have to click on 'options' or 'preferences' in the menu of your browser. #### **What is the impact of your cookie preference ?**

If you select a preference on the Satellic.be website domain, then this preference applies to all websites with "Satellic.be" (e.g. rup.satellic.be, tollcalculator.satellic.be) in the address managed by Satellic.

We process your Personal data based on your consent to send you the Satellic newsletter. You can opt-out from our newsletter (sent via e-mail) at any time and free of charge by using the unsubscribe link which is in the footer of all the newsletters you receive, or by sending an e-mail to [marketing@satellic.be](mailto:marketing@satellic.be).

##### *❖ [I am \(a contact person of the\) User OR I am a \(contact person of\) any other party with which Satellic does or intends to do business \(e.g. prospects, visitors of our office, suppliers\)](#)*

We process your Personal data for the purposes mentioned hereafter:

- when it is necessary for the performance of any contract to which you are a party, or in order to take the steps (at your request) which are necessary before you can enter into a contract;
- when it is necessary to comply with our legal obligations;
- when it is necessary for the purpose of our legitimate interests and/or the legitimate interest of a third party, e.g. to identify trends, to perform dispute management, for client and supplier relationship management, to ensure the security of our offices and the safety of our employees and visitors.

##### *❖ [I am an applicant](#)*

We process your Personal data in order to be able to take the steps (at your request) which are necessary before you can enter into a contract.

If we do not immediately enter into a contract with you, we process your Personal data for the purposes of our legitimate interests (e.g. to check in the future whether your profile matches with a new open position).

## 6. How long do we store your Personal data?

##### *❖ [I am a Website Visitor](#)*

We keep your Personal data for no longer than reasonably necessary for the fulfilment of the purposes for which your Personal data was collected.

As a rule, the personal data we obtain through the online contact & complaints form issued by third parties other than Users are stored for a period of one (1) year. However, the Personal data stored in the cookies is stored for the period defined in the cookie declaration.

Depending on the situation, we may retain your data for a longer period, in particular if any longer retention period is required by the law or if litigations or investigations still might arise after the end of the defined period.

##### *❖ [I receive the Satellic newsletter](#)*

We keep your Personal data for no longer than reasonably necessary for the fulfilment of the purposes for which the data was collected.

As a rule, your Personal data will be stored for a period of (3) three months after you have withdrawn your consent.

❖ [I am \(a contact person of the\) User or I am a \(contact person of\) any other party with which Satellic does or intends to do business \(e.g. prospects, visitors of our offices, suppliers\)](#)

We keep your Personal data for no longer than reasonably necessary for the fulfilment of the purposes for which your Personal data was collected.

As a rule, the Personal data processed in the framework of a contractual relationship is stored for a period of (10) ten years as from the date on which the contractual relationship ends.

The Personal data collected when you enter our offices and sign in at our reception desk will be stored for a period of (2) two years after the day on which it was were collected. The pictures collected via the cameras located at the entrance of our offices will be stored for a period of (30) thirty days.

Depending on the situation, we may retain your data for a longer period, if any longer retention period is required by the law or if litigations and/or investigations still might arise after the end of the defined period.

❖ [I am an applicant](#)

We keep your personal data for no longer than reasonably necessary for the fulfilment of the purposes for which your Personal data was collected.

Your Personal data used for the recruitment process will be kept during the duration of that process, and for a period afterwards if you become one of our employees. If you do not become of our employees, we will keep your personal data for no longer than five (5) years starting on the day on which we had the last contact with you.

## 7. With whom do we share your Personal data?

Your Personal data will be treated strictly confidentially. Our employees will have access to your Personal data on a strict need-to-know basis and for the purposes described in section 3 “why do we collect your personal data?”.

Your Personal data may be shared with the following categories of recipients:

- our subprocessors (e.g. internet service, payment processing providers, logistic providers);
- third parties: Business Partners, authorities, additional service suppliers and Satellic advisors and auditors.

Satellic itself does not transfer personal data to countries outside the European Economic Area. Certain Parties (e.g. Google), which Satellic relies on, and which have access to the (personal) data collected by cookies may transfer your (personal) data to a country outside the European Economic Areas. Please refer to the privacy and cookies policy (see reference link in section 3) of these third parties for more information about this transfer.

Satellic has concluded a processing agreement with these third parties. Furthermore we have made the use of these cookies as privacy friendly as possible by choosing to mask the last octet of your IP address and to disable the possibility of data sharing. You can withdraw your consent by changing the settings of these cookies at any time (see section 5). If you use Google Chrome, you can always install the google browser extension that provides an opt-out Google Analytics cookies.

## 8. Your rights concerning your Personal data

Subject to the conditions described in the applicable data protection legislation, you have the following rights with respect to your Personal data:

- the right to obtain access to the Personal data we hold about you and to obtain a copy of this data;
- the right to obtain the rectification of any inaccuracy in your personal data and the right to ask incomplete Personal data to be completed, insofar you were not able to correct or complete your data yourself on the Road User Portal;
- the right to obtain the erasure of your Personal data;
- the right to obtain the restriction of processing of your Personal data;
- the right to receive the Personal data you have provided to Satellic in a structured, commonly used and machine-readable format and the right to transmit this data to another controller (i.e. the right to data portability);
- The right to withdraw your consent to the processing of your Personal data at any time without affecting the lawfulness of the processing, if the processing is based on consent.

You have the right to object at any time to the processing of your Personal data for the legitimate interest of Satellic acting as Controller. Satellic shall act upon your objections unless there are compelling legitimate legal grounds for the processing of your data which override your interests, rights and freedoms, or for the establishment, exercise or defence of legal claims. If your Personal data is processed for direct marketing purposes (newsletters), you have the right to object at any time to the processing of your personal data for such marketing purposes. This also includes profiling to the extent that it is related to such direct marketing purposes.

To this end, if you want to exercise all your relevant rights, queries must be submitted as follows: complete and send us the [Data Subjects' Request Form](#). In addition, you can consult and/or amend your personal data yourself on the Road User Portal at any time.

If you have a complaint concerning the processing of your personal data, please complete and send the [Data Subjects' Request Form](#) as well, or write to our Data Protection Officer, Satellic NV, at 1831 Diegem, Airport Plaza Leonardo Da Vincilaan 19 A/4. Our Data Protection Officer will then analyse your complaint and work with you to resolve the matter.

**If such a query or complaint relates to the processing of your Personal data by Satellic acting as Processor for Viapass, Satellic will acknowledge your request and will ask you to submit your request directly to Viapass, the Controller, by sending an e-mail to [dpo@viapass.be](mailto:dpo@viapass.be).**

Satellic, **or as the case may be, Viapass**, will answer your query or complaint without undue delay and in any event within one month after the day on which your query or complaint was received. Taking into account the complexity of the request and the number of requests received, that period may be further extended with two months. You will be informed of such an extension during the first month following the receipt of the request. The reasons for the delay will also be specified.

If you still feel that your data has not been handled appropriately after we have responded to your request, you can, in accordance with the law, lodge a complaint to the Belgian Data Protection authority pursuant article 77.1 of the GDPR: by post to Drukpersstraat 35, 1000 Brussels, per e-mail to [contact@apd-gba.be](mailto:contact@apd-gba.be) or by phone +32 2 274 48 00.

## 9. Changes to our Privacy Policy

We may change our Privacy Policy from time to time. However, we will not reduce your rights granted by this Privacy Policy. Any changes we make to this Privacy Policy in the future will be posted on our Website at least 30 calendar days before entering in force. To let you know when we make changes to this Privacy Policy, we will amend the revision date at the bottom of this page. The new modified Privacy Policy will apply from that revision date.
